## THE SPECIFICS OF POLITICAL AND STATE MECHANISMS OF ECONOMY REGULATION IN PRESENT-DAY RUSSIA

The article is about the Russian system of the political and state mechanisms of economy regulation in the post-Soviet period, the topics being analysed by economic politology. ## EVALUATION OF KNOWLEDGE INPUT IN THE ECONOMIC GROWTH OF THE REPUBLIC OF BASHKORTOSTAN

The results of evaluation of the knowledge input into production are presented in the article. With the use of the model of Cobb-Douglas production function the author proves the gross regional product dependence on the number of people employed in the production and education investments including retraining in Bashkortostan. The graph of gross regional product clearly shows that coefficients estimated by linear regression give more accurate approximation if two parameters are examined (the number of people employed in the production and education costs including retraining costs). The influence of combined education costs is of average 7.21% of overall logarithm sum.
