On the other hand, according to established opinion the sphere of international and inter-ethnic relations requires exceptional finesse as there is a potential danger of socio-political outbursts with most serious consequences leading to the dissipation of state and the loss of sovereignty. In addition to that, the traditional forms of government institution are not able to effectively work in this field of interest because of the blurred outlines of the responsibility areas, inability to set particular goals and ambiguity of the national policy budgeting issues. The experience of the nationalities department which existed in Russia during the first post-Soviet decade showed that the above mentioned factors lead to the constant search for organizational forms and frequent senior management replacement. That interfered with the effective work and led to the dissolution of the department. The role of the government in the national policy implementation is examined in the article. The interdepartmental communications in this matter are illustrated.
