### HYBRID WAR AND COLOUR REVOLUTIONS IN WORLD POLITICS

The article is about the role of hybrid wars and colour revolutions in nowadays world politics. The hybrid wars are regarded as a new form of armed warfare in which the use of the armed force as such is not obligatory any more for defeating the enemy: in hybrid war "the hard power" is used combined with non-combatant methods of battling the enemy like information and psychological war, soft and smart power, economic pressure, isolation and blockade, traditional diplomacy. Colour revolutions are regarded in the article as technologies of staging coup d'etat by means of mass civil disobedience escalating into controlled civil riots. It is determined that colour revolutions are not the elements of hybrid wars; these are different, incompatible means of engaging the enemy. However it is the colour revolutions that dismantle political regimes and enable external aggression that evolves into a hybrid war. The author of the article also addresses the modern technologies of controlled chaos which performs a service function in colour revolutions.
